As the new president of your Pelican Lake Property Owners Association I am very excited to see what the newly elected board has already accomplished.

Your board received tentative approval of our 501C3 status. The designation is commonly called "Tax Free Status". This can have significant impact on our organization. We will be able to accept donations from large corporations and private citizens. Contributors will be able to use their generous donations as tax deductions! This can be a huge advantage to us as we try to advance clean water, clean environment and preserve this beautiful lake.

We established a website: www.pelicanlakepoa.org. The board feels this will enable us to ensure better communications with the membership. Check it out!

We applied for DNR permits to install 10 new fish cribs in the next two years. If anyone would like a crib in front of your home please let us know.

We have been awarded the stretch of highway 45 from County "B" to McGinnis Rd. for litter control. This Adopt-A-Highway program will give us the area right through Pelican Lake.

In September the DNR and Mole Lake did their annual fish shocking and they were pleasantly surprised by the

large amount of adult fish in Pelican Lake. Their report cites a good year class of walleyes and some year class Muskies, some of which were 45" to 49" fish. If anyone would like a copy of the report just let us know.

Another event being set in motion is a lake management study that was approved by the membership at the July meeting. We have received approval on two of the three grants needed to start the study in the amounts of \$7776.60 and \$9973.92. Hopefully the study will start by April.

The board has been very conscious of the needs of the members and we look forward to a great year of service.

Minutes of the Pelican Lake Property Owners Association Annual Meeting July 24, 2010

The annual meeting of PLPOA was called to order at 2:00 pm by President Kirby Ament. There were 95 members present.

Main areas of business will be

1. Election of PLPOA Board 2 Discussion regarding changing PLPOA to a 501(c)3 tax exempt organization 3. Discussion of a Lake Management Study for Pelican Lake.

Minutes of the spring meeting held April 10, 2010 were read by secretary Bob Mott and approved as read.

Treasurer Joe Altschaeffl gave a treasurer's report which was approved as read. Moved- Lucy Nelson 2nd Ethel Sturn Joe also recognized and welcomed new members to the association.

Members are asked to approach their neighbors and encourage them to join the association. There is strength in numbers.

AIS Report

Bob Mott reported that unlike 2009 a grant for \$8,200.00 was awarded by the State of Wisconsin to monitor two landings on Pelican Lake. Landings are monitored Friday afternoon, Saturday all day, and Sunday mornings from the start of May through the end of September.

Gary and Nancy Blumreich, our long time landing monitors return and are much appreciated. Two new part time monitors Jackie Belgnam and Kathy Handt have added to our efforts to protect Pelican Lake.

Some people have been disrespectful and rude to our monitors. If you see this - step in and support our monitors. If you are the offender-WAKE UP. These people are helping keep this lake the wonderful water body it is. HELP THEM-THANK THEM.

Thanks also to Jean Roach assisted by Lynn Anderson for arranging volunteers and setting workers times at the landings. Thanks also to Lucy Nelson for her work with the resorts and campgrounds on the lake.

Election-

Nominations were received for the six board member seats available. Barb Weaver-Krause chose not to run again after her two year term, Butch Kress resigned in mid-term due to family concerns, Kirby Ament completed his 6th year and resigned due to term limits. Bob Mott, Joe Altschaeffl, Dennis VandenHeuvel, and Larry Hahn (completed Butch's term) agreed to run for another two year term. Dan Miller and Cheryl Schmidt agreed to run for the open board positions. All candidates were unanimously elected to two year terms.

501(c)3

Ed Erickson who has headed up the investigation of gaining tax exempt status for the PLPOA through gaining 501(c)3 status reported to the members.

Bob, Ed, Kirby, and Joe met with Rhinelander CPA Laurie Weston to discuss the costs and procedure for becoming a 501c3. Ms Weston has experience with forming 501c3 organizations and is willing to work with the PLPOA in this venture.

Positives

- Total cost would be around \$ 1200.00 initially. Additionally, there would be a yearly filing fee
- PLPOA would be able to write off association dues
- PLPOA members and others can donate to the PLPOA and write off those donations
- PLPOA can solicit donations and grants from corporations

- PLPOA will become more up to date regarding tax status

Negatives

- PLPOA could not donate to political candidates

PLPOA member Mike Reece, experienced with 501c3 organizations, offered the following comments-

- PLPOA board has done extensive research concerning the 501c3
- Amount accumulated in PLPOA treasury may be red flag to IRS. The 501c3 status would resolve any conflicts and put PLPOA on good grounds with IRS
- PLPOA could set up a separate fund to receive donations from trusts etc.

Motion was made by Mike Reece to proceed with attaining 501c3 status 2nd Jean Roach, Motion passed 75-0.

Ed Erickson was directed by President Ament to continue pursuing 501c3 status.

The present Articles of Incorporation and By-Laws need to be adjusted to be in compliance with 501c3 status.

Question- Do members need to vote on changes?

Answer- Vote gave board authority to make needed changes. Changes will highlight the charitable nature of the organization. They will be minor and will be reported to the membership.

Question- Will there be any problem transferring funds from old PLPOA to new?

Answer- None are anticipated.

Question:- Are there limits to the kind of organizations to which PLPOA can belong?

Answer- Not to our knowledge. Ed will check.

Lake Management Study

Bob Mott reported on the proposed Lake Management Study

- Two year study

- Onterra, LLC from DePere, WI has given a proposal for the study The firm has done many studies in northern Wisconsin including projects begun this year at Summit Lake and Three Lakes. The company has done over 40 in the last ten years..

The grant supervisor in Rhinelander has worked with Onterra often over the past several years.

- The study will be 75% funded by the state of Wisconsin if the grant applications are approved. The PLPOA will be responsible for the rest with some of the costs being offset with in-kind work.

- Onterra will write and submit the grants.

- If the grants are rejected, there is no obligation of any sort for the PLPOA.

- Three Lakes was recently notified that “ unless they develop a Lake Management Plan, no further rapid response grants will be issued.”

A Lake Management Plan needs to be in place if long term state grants to fight AIS problems are requested .

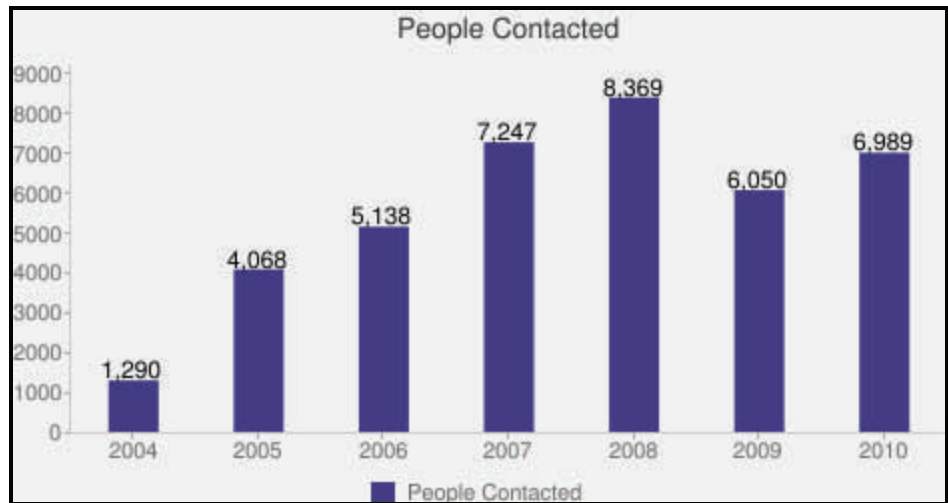

CLEAN BOATS/CLEAN WATERS




In 2010, 3203 boats were inspected at the two main landings. Some interesting statistics were that 7% of boats were on a different water body within 5 days, 100% claimed to have removed all plants before launching, 99% were aware of the launch law, 1% had plants present, 1642 people said that the inspectors provided main information

followed by boat landing signs and if we had a wash station 62% said they would use it.

GRILLED WALLEYE IN FOIL

- 2 # walleye fillets
- 2 tablespoons lemon juice
- 2 green peppers, sliced
- 2 teaspoons salt
- 2 onions, sliced
- 1 teaspoon paprika
- 1/4 cup butter melted
- dash of pepper

Wash fish, pat dry with paper towel. Cut into serving-size portions. Cut pieces of heavy-duty aluminum foil, 12 X 12 inches each: grease lightly. Place portion of fish on foil: top with green peppers and onions. Combine remaining ingredients: pour sauce over fish. bring foil up over food: close all edges with tight double folds. Place packages on grill about 5" from moderately hot coals. Cook till flakes.

TOWN LAKES COMMITTEES

In November, the town of Newbold became the first town in Oneida County to create a lakes committee. What is significant is what the mere creation of the committee means for Newbold and perhaps the rest of Oneida County. Though the area isn't short on lakes, Newbold is now the only town in the county with a lakes committee. Newbold committee chairperson, Scott Eshelman said he hopes more towns will consider starting such a committee in the future.

The primary objective of the lakes committee is to maintain the overall health of the lakes. A big part of that right now is controlling the invasive species that are gradually appearing in some lakes. These committees are comprised of local lake associations and volunteers. Vilas County has eight of fourteen towns with lake committees.

TAKE THE LEAD OUT, PLEASE!

In July a sick immature Bald Eagle was found at the Groeger cottage on Mekinak Point. Marge Gibson of REGI (Raptor Education Group, Inc. <http://www.raptoreducationgroup.org/>, near Antigo) came to the rescue. Mekinak Pt. residents and our Lake Association made donations to REGI to save our Eagle, but despite Marge's efforts, it suffered a painful death. The cause was lead poisoning from ingesting fish that had swallowed lead jigs and sinkers.

Although much money was spent along with the loving care of volunteers at Raptor Education Group Inc. (REGI) one Pelican Lake eagle (pictured right), died in July due to the effects of lead poisoning. Donations to REGI can be sent to them at REGI, P.O. Box 481 Antigo, WI 54409 or online.

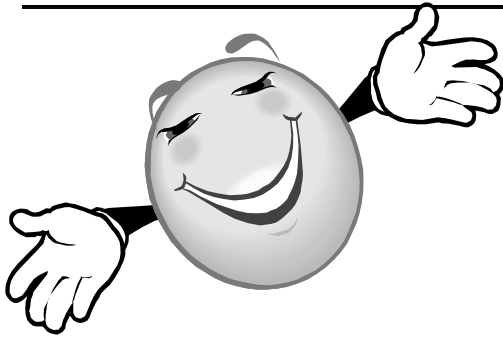


Unfortunately, efforts thus far to ban lead fishing tackle have been unsuccessful, due mainly to lobbying by Sports Fishing Groups organized by mega business interests such as Cabela's Sporting Goods. Their profits come before our raptors.

Upon hearing once again that these groups defeated a no-lead fishing tackle ban, Marge Gibson had this to say: "I am without words. I got the notice from the EPA. Sadly I got it minutes after I had a beautiful adult male Trumpeter Swan die in my arms from lead poisoning. I literally felt his heart stop beating. What a kick in the gut! Two days before that I lost an adult bald to lead poisoning. I am actually in FL now about to release two loons recovered at REGI. One had lead poisoning the other swallowed a hook and was wrapped in fishing line. What a sad statement by fishermen. The huge sport fishing lobby is taking advantage of the camaraderie of sportsmen, they (fishermen) should be furious this group, (Keep America Fishing, editor added) thinks they are so unintelligent they would not read facts for themselves."

While Marge's long struggle saving raptors continues, we on Pelican Lake can make choices that will protect our Eagles, Ospreys, Ducks, and Loons from a horrible fate. Non-lead fishing tackle can be purchased on the internet, and fishermen can request their local bait store to stock non-lead tackle. Fleet Farm responded to our inquiry and they do stock non-lead alternatives. The cost is only slightly higher than the lead equivalent, despite claims to the contrary, and is well worth protecting our great birds.

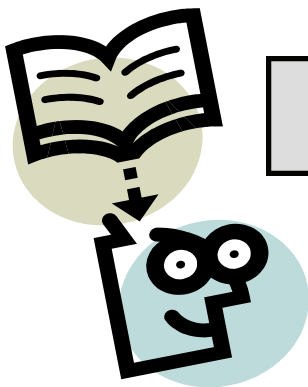
Many of us have watched with pleasure the growth of populations of Bald Eagles, Ospreys and Loons. The hauntingly beautiful call of the Loons, the majestic soaring Eagles and diving Osprey have become sights and sounds we love. We must not take them for granted. If we want to pass on God's majestic birds to our children and grandchildren, we need to act responsibly. Choose to use non-lead fishing tackle, and pass the word on to your friends and neighbors.

2010 AIS PROGRAM - PELICAN LAKE

The year 2010 brought us back to full scale AIS monitoring after a reduced program in 2009. The Pelican Lake Property Owners Association, the Town of Enterprise, and the Town of Schoepke share the costs of the monitoring equally. Thankfully, we were awarded a grant by the State of Wisconsin this year to support the Clean Boats/Clean Waters Education program at Keelers Landing and the State Landing. The grant was for \$8,200.00 and the total cost of the program was nearly \$ 11,000.00.

The two landings were monitored on Fridays from 3 to 7, on Saturdays from 6 am to 6 pm, and on Sundays from 7 am to 1 pm. Monitoring began the first weekend in May and ended the last weekend in September. There were reduced hours in September at both landings.

We were very happy to have our long time friends, Gary and Nancy Blumreich return as our primary monitors. This couple treats Pelican Lake as their own going beyond paid help to protect and enhance the lake. They help boaters land boats, share information about fishing and boating, and put up with endless complaints about water depth or lack of it, the DNR (which they don't represent), and even where the buoys are placed. Through it all, the Blumreichs stay positive and know how important their job is in preventing AIS from entering Pelican Lake.

We were also very thankful to have Kathy Handt and Jackie Belgnam as our full time substitutes. They did a great job when Gary and Nancy were gone. Please thank these people when you visit the landings.

There was only one confirmed sample of Eurasian Water Milfoil found at the landing this year. When a boater loaded his boat, milfoil was found on the trailer. The monitor was working with incoming boaters and was not able to find out if the boater had been at another lake with EWM recently. The boater left before that could be discovered. When his boat number was checked, the owner was not the same person or same boat.

The area around the landing was checked thoroughly and no samples were found in the lake.

During the year 3,203 boats were checked at the two landings, 6,989 people were contacted, and 974 hours were spent on the project. In checking records from around the area and state, Pelican checked the most boats by a wide margin. By comparison, Post Lake checked 1,938 boats and the Three Lakes Chain 1,789 boats. Crescent, Squash, and Lake Julia a total of 1,229.

PLPOA members should be proud of this accomplishment.

Special thanks goes to Jean Roach who did a masterful job in coordinating the landing workers with help from Lynn Anderson. Lucy Nelson assumed the job of working with the resorts and campgrounds on Pelican for the second year. This is a very important area to spread the word about invasive. Thanks, Lucy.

Finally, thanks to all of the volunteers who worked at the landings. Your hours are vitally important. Thanks also goes to the Town of Schoepke and Enterprise that continue to support the AIS program as well as Dick Dvorak, Schoepke Town Clerk, for his help in processing the checks for the workers.

With your help, we will continue to protect and enhance Pelican Lake and keep it AIS free.
