President's Corner by Jean Roach

We have bid summer goodbye and, as our fall season winds down, our thoughts turn to what the Pelican Lake Property Owners' Association has accomplished since our last newsletter.

The Summerfest Annual Meeting/Fundraiser was well-attended and a financial success. It was truly a team effort with over 50 volunteers doing everything from organizing the car show; buying, grilling, and serving the food; purchasing and selling beer, wine, and soft drinks; collecting raffle items and running the various raffles; to cleaningup the site the next day.

At the Annual Meeting, there were two informational presentations designed to inform us about steps we can take to foster a healthy lake. Rosie Page from the County Conservation Department addressed the subject of shoreline buffer gardens. Buffer gardens are native plantings used to replace lawns in areas within 35 feet of the water. This naturalization process is important in filtering excessive nutrients, thus preventing them from entering the lake. Excess nutrients are a cause of algae blooms.

Board Member Dave Hardt also gave an illustrated presentation on the algae-snail-duck relationship which results in swimmer's itch. This gave us another good reason to adopt practices which will lessen the nutrient flow into the lake. No one likes swimmer's itch!

The Association then announced that a sample shoreline buffer garden was in the works, with the help of volunteers to plan and plant it on land donated by the Town of Schoepke. In the spring of this year, our grant writer, Bob Mott, received funding from Lumberjack, LLC for this project. The purpose of the grant is to demonstrate the ease of changing a shoreline grassy lawn into an area of native shrubs, trees, and flowers. This native vegetation allows for natural views of the lake, while filtering excess nutrients that contribute to algae blooms. In addition, native plants require little maintenance and have no need for fertilizers. That's a good thing because fertilizers contribute directly to algae bloom and lake pollution.

After the Annual Meeting, we moved on to the enjoyment of food, drink, music, and raffle activities with our neighbors and friends. The day ended with a colorful fireworks display that many enjoyed from boats under the stars. A good time was had by all.

On a warm Saturday in September, a group of members led by Lori Regni came together to dig, plant, water, and mulch the first phase of the sample shoreline buffer garden. Their hard work was much appreciated. Work will continue next spring and we welcome all amateur gardeners to join in this worthwhile project. We hope you'll observe our progress and consider planting your own buffer garden along your shoreline. Folks are available to guide you through the steps, some of them master gardeners.

On October 18, thanks to Dan Miller and Jim Brust, our roadside clean-up organizers, lake roads were cleared of unsightly litter. Twice a year many members show up to help with this beautification project. This year, as a part of their community service, five students from Elcho also pitched in - a nice addition to our usual dedicated volunteers.

Thanks to many volunteers, the PLPOA has made useful contributions to our lake community. I'll end this message by asking that each of you consider how you might volunteer a few hours next summer on one of our projects, or offer ideas for new projects. Please take the time to read the articles in this issue for more in-depth information about our many activities. Together we can make a difference for Pelican Lake.

Electrofishing Survey by Larold Lodholz

The electrofishing survey for Pelican Lake was done on the evening of September 23, 2014. It was a beautiful evening, 50 degrees, and the lake was very calm. Bob Brautigam and Larold Lodholz met with John Kubisiak, Oneida County Biologist, and Mike Preul, the Mole Lake Fisheries Biologist, at the State Boat Landing at 6:30 p.m. In order to cover the 17 miles of Pelican Lake's shoreline, the two boats went in opposite directions around the lake.

The survey ended around 1:00 a.m. It was a lot of work!

This project is done annually. It really gives accurate information as to what's going on with the fish population in the lake. Overall, "it looks like a bright future for Pelican Lake's walleyes."

From The PLPOA Secretary by Vicki Smith

Members of the PLPOA met three times in 2014: May 31, July 19, and September 20. At the May 31 Meeting:

- 1. After much discussion, it was decided to continue having Summerfest.
- 2. An update was given on the Shoreline Buffer-Zone Example Garden located on the shoreline just north of the Schoepke Town Hall.
- 3. It was announced that the Clean Boats-Clean Waters program needed monitors for whom the Association would pay the training sessions.
- 4. Jean Roach announced that Phases I and II of the Lake Study Grant were completed. By unanimous vote, it was decided to write and submit a request for a \$16,000 grant (for which the state would pay 75%) for the hand-pulling of the Eurasian Water Milfoil (EWM).
- 5. Raffle tickets were given to various members for distribution to local businesses.

At the July 19 Meeting:

- 1. Rosie Page from the County gave a "Woody Habitat and Shoreline Restoration" presentation in which she emphasized how important it was to have a near-shore, shallow-water zone where plants can grow and sunlight can penetrate. Beavers, muskrats, minks, loons, herons, and green frogs all need this space along the shoreline. Loons and turtles, especially, need such a zone for nesting and reproducing. Woody habitats along the shoreline are also recommended. Two ways to to achieve these: (1) leave fallen trees in the water; and, (2) drop live trees into the lake, allow them to sink, then anchor them via 3/8" cables to the shore. Best time to do this: after November 1.
- 2. Dave Hardt gave a slide presentation, "Buffer Zones to Reduce Algae Blooms/Swimmer's Itch." He recommended that homeowners create a buffer zone along their shoreline to help filter out the phosphorus that comes naturally from rain and also from home activities. Rather than using fertilizers, he recommended using lake water on plants and grass because lake water is rich in natural fertilizer. Phosphorous-free soaps should be used for dishwashing, bathing, and washing machines. Be sure to check your septic system to see that it's functioning properly.
- 3. Photos were handed out showing 5 different shorelines, from urbanized to natural. Pelican Lake has a 16.4mile shoreline that is 24% (3.9 miles) urbanized and 17% (2.7 miles) developed-unnatural. The Association's goal is to encourage homeowners to develop natural buffer zones along their shorelines in order to reduce these numbers.
- 4. In addition to the Fish Report, updates were given on the AIS Grant and the Shoreline Restoration Project.
- 5. Officers were elected for the Board of Directors.

At the September 20, meeting:

- 1. Dave Hardt gave a power-point presentation, "All About Algae," showing the differences between green algae, a natural phenomenon in lakes, and the blue-green algae that appeared in Pelican Lake in August. To help avoid the blue-green algae, he recommended the following: (1) make sure your septic system is functioning property, (2) use lake water to water your plants/grass, (3) create a buffer zone of natural vegetation along your shoreline. Don't be alarmed by aquatic plants/weeds. They help keep the lake clean, as well as give off oxygen for the fish.
- 2. Updates were given on the Shoreline Restoration Project and the AIS Grant.
- 3. Other discussion topics: the placement of buoys for marking areas (responsibility of the Townships), cutting reeds in the lake to create a pathway for watercraft (okay, but please remove the reeds from the water), septic inspections (will be done by the county in 2016), a sponsor to pay for the printing of raffle tickets, and the creation of a welcome packet for new homeowners and those who are not yet members.
- 4. Raffle drawing winners: Joan Sage, Charles Propson, and Janice Hammen.



The remaining board members: Bob Brautigam, Cathy Cyrs, and Vicki Smith, began their second year of service in July.

Update on Eurasian Water Milfoil in Pelican Lake by Jean Roach



Dumping EWM harvested from lake for compost

The Pelican Lake Property Owners Association is continuing its efforts to control the EWM found in our lake. In June of this year, Onterra, our lake study biology consultants, sent a team to survey the lake. The results showed some re-growth of colonies along the west shore of Musky Bay, and a new colony in Treacherous Bay.

In August a group of hired divers spent two days handpulling the invasive weeds. Unfortunately, the cloudy water created by the algae bloom coincided with their work. While that didn't impede their visibility along the Musky Bay shore where it was shallow, it did affect their ability to work in Treacherous Bay.

Onterra later returned to do a survey after hand-pulling. Musky Bay shore areas were clear, however a new area in Musky Bay was found, one which was not visible in June. In addition, it was noted that the area in Treacherous Bay had expanded. Those two areas will be our target for next season, most likely for another round of hand-harvesting.

Our goal is to contain the EWM, not to eradicate it. No lake has successfully eliminated it, but it's possible to keep

it from taking over the lake. All of us can do our part by cleaning our watercraft of any weeds when we return to shore, and disposing of them away from the lake. Also, it is helpful to avoid the areas where EWM has been identified. Maps of these areas are available at the landings and on our website.

Spending a few hours every summer checking out the plant life in your area and looking for invasive weeds could help in identifying any area of new growth. If you let us know how much time you devote to this, we can use your hours as donated time toward our grant-matching requirement.

Lose the Lead – Save a Loon

We share our waters with a rich variety of wildlife. The Common Loon is one of the Northwoods favorites. Did you know that loons can live over 30 years and return to the same lake year after year? When they arrive each spring, it's like welcoming back a family member. One way we can help protect loons is to stop using lead fishing tackle. Research has proven conclusively that ingested lead kills loons by poisoning them. For a list of nonlead tackle suppliers visit www.northland.edu/loonwatch.

If you're not returning until the weekend, ask a neighbor to put your garbage can away after the garbage has been picked up.

Kevin Worrall Memorial Musky Classic Tournament by Sherri Gerrits

Gerrits' Lakeview held the 23rd annual Kevin Worrall Memorial Musky Classic Tournament on September 6, 2014. This tournament is a benefit event, held in remembrance of Kevin Worrall. All of the proceeds go to the Ronald McDonald House in Marshfield.

This year we were able to donate a huge amount: \$8,079!! Since we've started this tournament, over \$34,000 has been donated to the Ronald McDonald House. This is, in great part, due to the generous people who helped out at this event: the volunteers, sponsors, and musky fishermen. A big thank you goes out to everyone who participated.



Regarding this year's tournament, there were a total of 106 boats. Once again, Lakeview provided the awesome bonus prize of a 2015 fully-rigged Tuffy boat for the first 50-inch musky caught. In addition, if that musky were caught using a Suick lure, that fisherman would receive an additional \$10,000 in cash. Although some big muskies were seen, no one was able to capitalize on them.

A total of 6 muskies were caught. The first-place team of Wild/Forcier doubled up with two of them. Here's a list of the muskies caught, all of which were successfully released:

Visit to the Sokaogon-Chippewa Community by Jean Roach

On September 27, 2014, a group of Association members visited the Sokaogon-Chippewa Community Headquarters in Mole Lake to personally thank the Tribe for its generous donation of \$5,000 to the PLPOA. We met with Tribal Chairman, Chris McGeschick, and Fisheries Biologist, Mike Preul.

Together we spoke about our common interests. The Chairman elaborated on the importance of healthy water and forests as something the Tribal Community values as part of its heritage. The idea of passing on the earth to the next seven generations is their guiding principal. Members of our

Association articulated their mission to be good stewards of Pelican Lake and the surrounding forests for our current enjoyment, as well as for the future. Like them, many of us hope to pass down our lake cottage and a love of the Northwoods to our children and grandchildren.

After our discussion Mike Preul gave us a tour of the new fish hatchery pond complex. Currently there are



four ponds where primarily walleyes are raised for stocking area lakes. The Tribal Community plans to expand this operation over the next few years by adding more ponds and perhaps diversifying the fish they raise. Because Pelican Lake's walleye population is selfsustaining, at this point we have not received any of their fingerlings. However, if this situation changes, we will benefit from the Tribe's important work.

Both McGeshick and Preul expressed an interest in working with our Association on projects of mutual benefit in the future. There are state grants that may be a good fit for our two groups to work on

cooperatively. McGeshick and Preul also offered an open invitation to all of our members to tour the fish hatchery. Their contact information is:

New DNR Grant Compliments PLPOA Goal to Naturalize Shoreline

It's designed to encourage simple lakeshore projects to boost healthy lakes.

The Department of Natural Resources recently introduced a new grant tool for lakeshore property owners in Wisconsin. The Healthy Lakes Project, according to the DNR, "aims to fund individual local projects around the state that focus on simple ways to improve fish habitat, integrate native plantings, divert and clean runoff water, and promote natural beauty."

Here are the basics of the grant:

Awards in amounts of up to \$1,000 will be given out to property owners for small-scale projects.

The deadline is February 1, 2015.

Eligible projects include:

- "Fish sticks" (trees placed in the water to serve as fish habitat).
- Native plantings.
- Runoff diversion projects.
- Rock-infiltration pits or trenches.
- Upland rain gardens.

The purpose of the PLPOA is to preserve, protect, and enhance the water of Pelican Lake, Wisconsin, through the undertaking of various activities, including advocating and facilitating communications through sharing of information between individuals, environmental organizations, and state and local governmental bodies. This includes involvement in various educational and special projects aimed at good stewardship and wise use of our waters, their natural wildlife habitats and fisheries both for us and future generations.

Clean Boats - Clean Waters by Lucy Nelson

This is the ninth year that I've taught the AIS class to Elcho students at their Forest Day, May 30. The class is a mixture of third through sixth-grade students. The programs the Forest Day covered were: Forest Finds, Aquatic Invasive Species, Birds of Prey, Geo-Cache, Castings, Nature Walk, Art Project, and Maple Syrup.

It's amazing how aware the students are of AIS. Some of my questions (along with their responses) were: "Where did AIS come from?" (Europe), "What does AIS do?" (crowds out other weeds that are good for the lake and for the fish), "What is a Zebra Mussel?" (it's a small hard



shell that can cut our feet if we step on it without wearing water shoes), and, "What should we do with our boat trailers?" (remove all the leaves before leaving the boat landing).

I also asked the students, "How many of you fish?" In response, most of the boys and some of the girls raised their hands. A few said, "Yuck. No way!"

When I showed the students the twelve specimens that I brought from the DNR, they couldn't wait to hold them. Their questions regarding each specimen were numerous and challenging. I truly enjoy teaching these students!

What You Can Do to Minimize our Algae Problem

This year the algae bloom was identified as blue-green algae. These blooms can produce harmful toxins known as cyanotoxins which can cause illness in humans and pets. It is always important not to ingest the water when the blue-green algae blooms are present. In August of this past year an advisory from The Oneida County Health Department was issued for Pelican Lake.

Property owners can help minimize the occurrence of blue-green algae



blooms by:

- Maintaining native buffer vegetation along the shore.
- Reducing and or eliminating fertilizer on lawns.
- Using only phosphorus- free fertilizer. (If you must)



• Upgrading or repairing septic systems. Anyone with questions about their sanitary system should contact a licensed plumber.

Shoreline Restoration Project Update



Phase One of the restoration project, located next to the Schoepke Town Hall, has been completed. This phase consisted of the engineering plan and the construction of a handicapped walkway to the near-shore area. The restoration plan for native

plants was created by Lori Regni and Lynn Anderson, Master Gardeners.

In late September trees and shrubs were planted by a group of volunteers. This volunteer community effort will continue in the spring with the planting of the ground covers. An e-mail alert will go out for help with planting, so stay tuned!
